AMENDMENTS intended to be proposed by Mr. INHOFE to the amendment (No. 3464) proposed by Mr. THUNE (for himself and Mr. NELSON)

Viz:

- 1 On page 75, beginning on line 11, strike “integra-
- 2 tion” and all that follows and insert the following: “inte-
- 3 gration into the national airspace system of small un-
- 4 manned aircraft systems that are capable of navigating
- 5 beyond the visual sight of the operator through an auto-
- 6 mated onboard control system or via a data downlink that
- 7 provides the operator a virtual means of onboard naviga-
- 8 tion”.

1 On page 80, between lines 11 and 12, insert the fol-
2 lowing:

3 “(h) NONAPPLICABILITY TO MODEL AIRCRAFT.—
4 This section shall not apply to model aircraft, as defined
5 in section 44808, and operating in accordance with that
6 section.”.

7 On page 99, beginning on line 19, strike “specific
8 only” and all that follows through “model aircraft” on line
9 20, and insert the following: “applicable to an unmanned
10 aircraft operating as a model aircraft or an unmanned air-
11 craft being developed as a model aircraft”.

12 On page 100, beginning on line 11, strike “, where
13 applicable” and all that follows through “the operation
14 from each” on line 15, and insert the following: “with
15 prior notice, where applicable, and coordinates with the
16 airport air traffic control tower, to the extent practicable,
17 when an air traffic facility is located at the airport, with
18 respect to the operation”.

19 On page 101, beginning on line 2, strike “adminis-
20 tered” and all that follows through “section 44809” on
21 line 5, and insert the following: “developed and adminis-

1 tered by the community-based organization for the oper-
2 ation of model aircraft”.

3 On page 101, lines 10 and 11, strike “with govern-
4 ment and industry stakeholders, including” and insert
5 “the”.

6 On page 104, strike lines 1 through 3 and insert the
7 following:

8 (1)(A) the individual has successfully completed
9 an aeronautical knowledge and safety test under
10 subsection (c); or

11 (B) the individual is operating a model aircraft
12 under section 44808 and has successfully completed
13 an aeronautical knowledge and safety test in accord-
14 ance with the safety program of the community-
15 based organization described in subsection (a)(7) of
16 that section;

17 Beginning on page 106, strike “introduction” on line
18 25 and all the follows through “unmanned” on page 107,
19 line 1, and insert the following: “initial retail sale any un-
20 manned”.
